- DATES: THURSDAY, August 5, 2021 at 6pm (1) Absolute deadline to register for MISS, TEEN, and MS Division contestants and pre-registration deadlines for all other divisions. No exceptions. (2) A mandatory MISS division info meeting will be held via Zoom. Participation is mandatory for ALL Miss Contestants. No exceptions.

DUTIES: With the exception of contracted titles, each titleholder has the following responsibilities:

- 1) Attend the Scott Boudin Festival on April 22<sup>nd</sup>, 23<sup>rd</sup>, & 24<sup>th</sup>, 2022 to introduce themselves on-stage at least one time per day, represent their title, and have fun.
- 2) Attend the 2022 Scott Boudin Festival Pageant in August 2022 to welcome your successor.
- 3) Represent the Scott Boudin Festival with grace and dignity.

## IMPORTANT UPDATES AND CHANGES FOLLOWING COVID-19:

- 1) Royalty CROWNED in 2021 will reign over the festival held in APRIL 2022
- 2) Royalty CROWNED in 2021 should attend the 2021 Boudin Festival in banner, but MAY NOT UNDER ANY CIRCUMSTANCE wear crowns to the SEPTEMBER 2021 Festival
- 3) Royalty CROWNED in 2021 WILL NOT travel until SEPTEMBER 27, 2021 after the 2021 festival
- 4) Miss Queen Crowned in 2021 will ATTEND LAFF in 2022 as a guest and COMPETE AT LAFF in 2023
- 5) Beginning in 2021 and GOING FORWARD, the Pageant will be held in AUGUST EACH YEAR

AWARDS: Queens receive a custom designed rhinestone crown and embroidered banner. First, second, and third alternates in each group receive a custom designed platter.

Miss, Teen, and Ms. Queens have contracts that accompany their titles. Contracts must be signed at a Welcome Meeting to be scheduled after crowning. These contracts identify the duties and responsibilities of the Miss, Teen, and Ms. Queens.

COMPETITION: All Contestants will compete in a modeling and beauty competition. We reserve the right to break or combine divisions.

Miss, Teen, and Ms. Contestants should be prepared for a round robin style interview, on-stage introduction, and on-stage question. These facets of the competition will test contestants' conversation skills, public speaking skills, knowledge of the Scott Boudin Festival, and understanding of their title responsibilities.

VENDORS: A photographer may be available. Refreshments and pageant rhinestone items will be available for purchase from vendors.

There is NO ONSIGHT dressing, hair, or makeup, a banquet room will be available at the Holiday Inn in Scott for contestants to get ready.

REMINDERS: Deadline for pre-registration entries is <u>Thursday, August 5, 2021 at 5:00 p.m.</u> Any registrations after this time must be made in person at the festival with cash payment of registration fee and late fee. There will be no exceptions. Miss, Teen, & Ms. contestants CANNOT register at the door. No exceptions.

Event admission is \$5.00 for everyone regardless of age. Everyone <u>except the</u> <u>contestant</u> must pay door admission. Please advise your guests accordingly.

Bad sportsmanship will not be tolerated by any contestant, representative, sponsor, family, friend, or parent. Bad sportsmanship will result in disqualification of the represented contestant and the individual will be asked to leave without benefit of a refund. This includes disrespectful comments and hurtful words about contestants. Judges' decisions are final. You may purchase score sheets for \$5.00 (cash only) on pageant day at the Registration Table.
